In this process, MCCC will compare information from your 2023-2024 FAFSA with this form, if applicable, copies of 2021 U.S. Federal Tax Return Transcripts, or with W-2 forms or other financial documents. Information retrieved using the Internal Revenue (IRS) Data Retrieval Process and not subsequently changed, is considered acceptable documentation for IRS-related information, and your Federal Tax Return Transcript will not be required.

The law requires us to ask for this information before awarding Federal Aid. If there are differences between your application information and your financial documents, MCCC will need to make corrections. If you do not complete this form or submit all of the required documents requested, we will not be able to complete the processing of your financial aid.

- Review your Student Aid Report (SAR), information request emails from the Financial Aid Office, and the Student Self Service to see if
 you need to submit other documentation (such as default clearance letter, citizenship documentation, social security card, admission to

- 3. Submit the completed worksheet, tax return transcripts, and any other documents to Financial Aid Office.
- 4. After a financial aid representative reviews your information, you may be asked to submit additional documentation. When all the information has been reviewed and any necessary corrections made, you will be notified about financial aid awards and payments.
